ASIA	China	BEJING			China has not closed its borders for students wishing to return to China. However, the Chinese government is taking very cautious measurements to prevent cross infection from increasing imported cases. For example, international flights to Beijing will be redirected to 12 designated cities in China first and then take healthy passengers fly back to Beijing. You can find more details here. Most other provinces require all passengers to take 14 days self-isolation and foreigners could be asked to take quarantine at a local designated isolation center.)

In order to minimize imported infections, China has announced a temporary ban on all foreign visitors even if they have visas or residence permits. This suspension doesn't apply to diplomats or those with C visas. People with emergency humanitarian needs or those working in certain fields can apply for exceptions. China is also limiting Chinese and foreign airlines to one flight per week and flights must not be more than 75% full. Authorities in Southwest China (Chongqing, Sichuan, Yunnan and Guizhou) have put in place restrictions for foreign visitors who will be ordered into a mandatory 14-day quarantine in designated local facilities upon arrival. Accommodation and meals related to such quarantine will be at visitors' own expense.
ASIA	Hong Kong	HKONG	Carol Cheung	<a href="mailto:Carol.Cheung@international.gc.ca">Carol.Cheung@international.gc.ca</a>	Starting from March 19, all arriving passengers who have been anywhere outside of Hong Kong in the last 14 days, regardless of whether they are Hong Kong residents or not, will be required to undergo a mandatory 14-day quarantine and medical surveillance. The travelers will be required to wear electronic wristbands and use a smartphone app to make sure they remain in isolation for a compulsory 14-day quarantine. This arrangement will take effect for three months. The HK Government has also announced that it will ban non-Hong Kong residents, including transiting arrivals, coming from overseas countries or territories, including mainland China, Macau or Taiwan, arriving at the airport from entering Hong Kong from March 25. The ban will last 14 days. The Hong Kong government had closed most of its border checkpoints with mainland China, except the three borders (Shenzhen Bay port, the Hong Kong-Zhuhai-Macau bridge and the airport), since 8 February. Hence, no Indian student may leave abroad nor any Indian student studying abroad can come back at the moment. The only exception may be an odd evacuation exercise done by the Indian government for its citizens stranded in a country.

After South Korea raised its alert level to the highest level "red" on Feb 23rd, it has implemented strong measures including temporary shutdown of schools at all level. After the winter break, Korean schools were supposed to start on March 2nd but as of March 27th, the school opening date is delayed until Monday, April 6th. (Source: ROK Ministry of Education)</p> <p>While Korea has not restricted air travel to Canada, many airlines have made and are likely to make commercial decisions to reflect these recent changes. In Korea, direct commercial flights between Seoul, Vancouver and Toronto will be impacted. Air Canada will suspend direct flights from Korea to Canada from April 1 to April 30 and Korean Air will suspend direct flights from Korea to Canada from April 3 to April 30. From April 3 onwards, non-direct commercial travel between Korea and Canada is expected to continue. Travelers from Korea can use a local carrier to transit through cities such as Tokyo, London, Paris, Frankfurt, Los Angeles, New York JFK, San Francisco, Seattle and Washington where Air Canada flights are available to one of four designated Canadian airports (Vancouver, Calgary, Toronto, Montreal).</p> <p>Some countries have begun to impose entry restrictions on travellers from South Korea because of the COVID-19 virus. If you are planning to visit other countries after South Korea and before you return to Canada, please check for any new health-related entry requirements on your itinerary.</p> <p>In-bound travellers to Korea will undergo fever checks and will have to submit the Health Declaration form and the Travel Record Declaration form when they arrive at the entry hall of the airport. Travellers who do not have fever or other symptoms will be able to proceed with the usual immigration procedure to enter Korea. Travelers who have fever or other symptoms will be escorted to the screening station for an epidemiological survey and, if necessary, will be tested for COVID-19. If the test result is negative, they will proceed with the entry procedures to enter Korea. If the test result is positive, they will be quarantined and hospitalized for treatment. It should be noted that Thai must do an online request in order to get this letter. The airports will be closed at some point in near future, once Thai nationals have traveled into Thailand, and all flights to Thailand are cancelled. The current stage of emergency is effective until April 30.</p> <p>People who return from Canada is required self-quarantine for 14 days, but there is no clear directions yet, whether it will be strictly forced as a prepared facility after the emergency situation order is in use.</p> <p><b>Travel from Thailand to Canada</b></p> <p>Based on yesterday's advising on flights to return to Canada, these airlines still operate flights to Canada as of yesterday: ANA, Lufthansa, Korean Airlines, Qatar Airways, China Southern Airlines. This may change in near future.</p>

All Vietnamese returning from overseas will be quarantined for 14 days. Due to capacity overload of quarantine areas in Ho Chi Minh City and Hanoi regions, Tan Son Nhat Airport (HCMC) and Noi Bai Airport (Hanoi) were instructed to stop receiving Vietnamese passengers from overseas, starting March 25 - 31 and March 26 - 31 respectively. From March 30 - April 15, almost all domestic flights from/to Ho Chi Minh City and from/to Hanoi are stopped, only a limited number of routes still operational: i) Hanoi - HCMC - Hanoi, ii) Hanoi - Danang/Phu Quoc - Hanoi, iii) HCMC - Danang/Phu Quoc - HCMC. The main Brazilian airlines have signed an agreement to exempt their passengers from fees for rescheduling their tickets, so several flights are being canceled due to the lack of passengers. In case of travel, it is recommended to contact the airline to confirm the flight conditions.</p> <p>As of March 23rd, a 30-day restriction on the entry of foreign passengers from China, European Union member countries, Iceland, Norway, Switzerland, the United Kingdom and Northern Ireland, Australia, Japan, Malaysia and South Korea. Canada was not mentioned.</p> <p>The restriction does not apply to native or naturalized Brazilians, immigrants with prior residence permit in Brazil, foreigner who will meet with Brazilian family member in the country or people authorized by the government in view of the public interest. The measure also does not affect foreign professionals in the service of an international organization, foreign employees authorized by the Brazilian government and cargo transportation.</p> <p>Specific recommendations for foreign students have not been issued by Government Officials.</p> <p><b>Air Canada will cancel all flights to Brazil starting March 28 until TBD.</b></p>

The Australian Government's position that schools should stay open is supported by the Australian Health Protection Principal Committee (AHPCC) — the key decision making committee on health emergencies.</p> <p><b>NSW:</b> Schools remain open but it is up to parents to decide whether to send children to school, and parents have been advised to keep children home unless they need to work.</p> <p><b>Queensland:</b> Schools remain open but it is up to parents to decide whether to send children to school. The Queensland Teachers Union has asked that schools shut or go 'pupil-free' so that teachers are shielded from the virus and can focus on mass remote learning.</p> <p><b>Victoria:</b> Schools closed for school holidays. Due to return on 13 April.</p> <p><b>ACT:</b> Schools are 'pupil-free' until the school holidays, but open to students who absolutely need to attend, such as those whose parents must attend work and cannot care for their children at home, as well as vulnerable children and those with additional needs. No child will be turned away.</p> <p><b>Tasmania:</b> Tasmanian Premier Peter Gutwein said while schools remained open for now, they would close to students after Friday next week. From the 6th to the 9th of April schools would be student-free. The Tasmanian school term will end four days early to give teachers time to plan to provide home learning delivery for students.</p> <p><b>Northern Territory:</b> Schools to remain open but optional for parents to send children. While classes in the Northern Territory are still planned to go ahead until the holidays, some schools have been preparing for weeks to make the switch to online learning.</p> <p><b>South Australia:</b> Schools remain open but premier Steven Marshall recognises parents will take children out of school, allowing for increased social distancing.</p> <p><b>Western Australia:</b> Schools remain open but laws relaxed so it's not compulsory. Resources will be provided for students to continue their studies from home for the remainder of the term. The WA Education Department has launched a new website called Learning at Home to help parents access those resources. The State School Teachers' Union of Western Australia is urging the state government to shut schools immediately, saying educators need time to prepare for the next phase of remote learning.</p>

Schools across Australia remain open but confusion remains around the definitions of essential work and whether parents should send their children to school or not. There have been reports of some parents' children being turned away from schools in New South Wales and other states, despite the state and federal government's assurances that no student will be turned away.  Teachers' unions worried about the health of their members have secured a meeting with Prime Minister Scott Morrison after issuing an escalating series of threats at state level.</p> <p><b>Tertiary</b>  Universities and other tertiary education providers were first hit by Covid-19 at the beginning of the school year (March), when 100,000+ students affected by the ban on travelling to Australia from China.  Universities responded by:</p> <ul style="list-style-type: none"> <li>· Offering discounted tuition to students stranded in their home country</li> <li>· Offering "support grants" of up to \$7,500.00 AUD depending on the institution for students attempting to travel to Australia</li> <li>· Advising students to get around the flight ban by quarantining themselves for 14 days in a third country unaffected by the ban.</li> </ul> <p>The economic effect of losing Chinese students led some universities to take more drastic action, citing an unsustainable reliance on China as a source of international students. The University of Tasmania slashed their degree offerings from about 514 to 120 by 2021.  Some universities have had confirmed cases of Covid-19 on campus. Responses have been:</p> <ul style="list-style-type: none"> <li>· Suspending classes for a week</li> <li>· Suspending all on-campus learning (libraries and services on campus still open)</li> <li>· Temporarily cancelling coursework</li> </ul> <p>On 18 March, the Federal Government announced "university and higher education should continue at this time with risk mitigation measures".  A host of universities – the University of Queensland, University of Melbourne, University of Adelaide, University of Wollongong and University of Technology Sydney, among others – are rushing to transition their courses online. The Australian National University is pausing its teaching for a week from 23 March and says it is "stopping face-to-face teaching for lectures and moving to remote participation". The University of Sydney and Southern Cross University have each committed to delivering all of their classes remotely from 23 March.  As of 24 March – the Federal government announced that about 230,000 students would receive increased welfare payments under the \$66 Billion coronavirus stimulus package. Students receiving Youth Allowance, Austudy and Abstudy will temporarily receive an increase to their payments and the waiting period and assets test requirements will be waived.</p>
